HORSE ID INFORMATION

Again this year, we are asking all members with horse projects to enter ID information into 4honline including pictures of your horse. This replaces the paper form that has been used in the past. Information must be entered **no later that May 1**, **2023**. Be sure to add information about a back up horse if that applies. Unfortunately this information does not carry over year to year so even if you entered the information last year, it needs to be added again this year. If you need help with entering your animals in 4honline, you can contact your advisor or the Extension Office.

EquiSTEP

There are new equine safety training requirements in place for 2023 and moving forward! EquiSTEP is Ohio 4-H's Equine Safety, Training, and Education Program and it is an annual requirement for <u>ALL</u> Ohio 4-H youth enrolled in a horse project. QUALITY ASSURANCE

Each Junior Fair youth taking a market or lactating animal to the Preble County Fair must participate in the Quality Assurance Program (QA) by attending a QA class each year. A reminder that a parent or guardian MUST attend QA with any exhibitor in grades 3-8.

YQCA information: Youth in grades 9 —12 are eligible to complete QA online. The YQCA website is https://yqcaprogram.org/. Instructions for this website are posted at preble.osu.edu.

ROYALTY CONTEST

Applications for Junior Fair royalty are posted on the Extension website.

Applications are due by May 1. Applications can be dropped off to the Extension Office. If we are not open, there is a basket on the bookcase in the lobby where applications can be dropped.

RABBIT CHECK INS

All breeding and market rabbits are required to come to check in days. Mark your calendars...

Breeding Rabbit Check-In Friday, June 23rd from 7—9 PM at the south side of the Expo Market Rabbit Check-In Friday, July 7th from 7—8 p.m. outside the Toney Building

If an exhibitor is not available to bring the rabbit(s) to the check in, a representative may bring the animal(s).

POULTRY CHECK IN AND POLLURUM TESTING

All fancy birds are required to come to a check in Friday, June 23rd from 7—9pm on the south side of the Expo Center. The bird's information will be verified and committee members will be available to answer questions.

Pollorum testing: Any show bird coming to the fair needs to be tested with the exception of birds under one year that have hatchery papers. Turkeys must be tested by a veterinarian. More information to follow on the Pollorum Testing for June 23rd during the check in.

FEEDER CALF TAGGING

Feeder Calf Tag In will be Saturday, June 24th from 8am to 10am.

LAMB AND GOAT WEIGH IN

The mandatory tagging and weigh in for market lambs and goats is on <u>Sunday, May 7 2023</u> from 1 – 4 p.m. at the fairgrounds. All market lambs must have scrapie tags at the weigh in. Lambs and goats must have bands for castration. DNA samples and paperwork will be collected at that time. Tags will be purchased the day of weigh in for \$5 each (1 per animal tagged). DNA tubes must also be purchased at a cost of \$5 (1 per animal tagged). Be prepared to pay that day.

PLEASE NOTE: Add all of your market goat/market lamb entries into Fair Entry at <u>preble-county.fairentry.com</u> by 11:59 p.m. on Thursday, May 4, 2023. Complete required fields. Pictures are not required.

This information needs to be in the system **BEFORE** you go to the scale on Sunday.

MARKET HOG TAGGING

Hogs must be tagged by **Sunday**, **May 7**, **2023**. DNA Samples and paperwork must be turned in by 4pm that day

Tags and taggers are available at the SFB office! The cost of tags is \$5 and the cost of the DNA tube is \$5. Taggers are available to borrow. Please do not wait until the last minute.
